"While both El-Sayed and McMorrow position themselves as champions of the middle class and affordability for average Michiganders, they might potentially be millionaires. Financial disclosures filed in 2025 with the U.S. Senate showed that McMorrow estimated her net worth between \$588,041 and \$1.87 million, much of that money coming from diversified investment accounts, many of which are associated with her husband, Ray Wert. The same disclosures filed by El-Sayed show that he estimated his net worth between \$586,022 and \$1.66 million, which includes two rental properties valued, respectively, up to an estimated \$250,000 and \$500,000, each. It would also identify factories and facilities that release PFAS into the air. U.S. Rep. Haley Stevens, D-Birmingham, is the sponsor of the bill. She said in a statement the Prevent Release of Toxic Emissions, Contamination and Transfer (PROTECT) Act would ‘close major regulatory gaps and strengthen federal oversight of PFAS air pollution.’ [...] Stevens added that the bill would ‘identify PFAS chemicals in our airways and to work to close loopholes,’ and ‘identify the bad actors so we can remove those chemicals.’” [WCMU, [1/23/26](#)]
